Cleaning of rooms and resources  All resources that have been used are cleaned every day.  Surfaces are wiped down regularly and at the end of every day.  Floors are vacuumed and moped daily.  All curtains and carpets are sprayed daily with antibacterial spray.  Carpets are steam cleaned weekly.  Toilets are cleaned regularly throughout the day	<ul> <li>minimised in most cases this is deemed not necessary.</li> <li>Resources such as cushions and soft toys have been removed.</li> <li>Children's free access to all toys has been restricted to allow us to keep on top of cleaning everything that has been used.</li> <li>All toys and resources are wiped down or washed every day.</li> <li>Children are not allowed to bring in toys from home.</li> <li>Dressing up clothes (only those that do not need to be pulled on over the head) and dolls clothes are washed daily.</li> </ul>	Managers and all staff
<ul> <li>Snack and lunch times</li> <li>Snack will be cut up in the kitchen by a member of staff wearing gloves or freshly washed hands.</li> <li>Tables will be wiped with antibacterial spray.</li> <li>Snack plates will be passed around by staff, where possible the children will use tongs to pick up their pieces of fruit, if they cannot manage this by themselves, staff will support them.</li> </ul>		Managers

Uniform Staff will wear black trousers and uniform top. Uniform tops (T-shirts and hoodies). Staff using public transport will change into their uniform once in the workplace Staff change their uniform top before leaving work as close contact with children could have resulted in the virus being transferred to clothing. These steps are to be taken daily to minimise the chance of cross infection.	A shower is available on site if needed.	All staff
Where the Risk Assessment identifies wearing of PPE as a requirement of the job (for example gloves for nappy changing), an adequate supply of these will be provided. Staff will be instructed on how to remove gloves carefully to reduce contamination and how to dispose of them safely.  Aprons, visors and face masks are available, these should be used when looking after a child who becomes unwell whilst at nursery.	• Staff to be reminded that wearing of gloves is not a substitute for good hand washing and to ensure that aprons, gloves and mask are destroyed after each use.  Managers to ensure sufficient availability of PPE.	All staff are responsible to be aware of changes in children's health throughout the day and to inform the person in charge of these changes.

## Symptoms of Covid-19

If anyone becomes unwell with a new, continuous cough or a temperature in Nursery they must be sent home and advised to follow the staying at home guidance.

If a child is awaiting collection, they should be moved into the outside area. If it is not possible to isolate them, move them to an area which is at least 2 metres away from other people.

If they need to go to the bathroom while waiting to be collected, they should use a separate bathroom if possible, which will be cleaned thoroughly before another person uses it.

## The bathroom should be cleaned and

disinfected using standard cleaning products before being used by anyone else.

In an emergency, call 999 if they are seriously ill or injured or their life is at risk. Do not visit the GP, pharmacy, urgent care centre or a hospital. If a member of staff has helped someone who was taken unwell with a new, continuous cough or a high temperature, they do not need to go home unless they develop symptoms

## Children with a temperature over 37.8

and/or a new persistent cough will not be allowed in the nursery.
Children's well being will be closely observed throughout the day. If any concerns arise the parent/carer will be contacted and asked to pick up the child immediately.
Internal communication channels and cascading of messages through line managers will be carried out

line managers will be carried out regularly to reassure and support employees in a fast-changing situation.

Line managers will offer support to

staff who are affected by
Coronavirus or has a family
member affected.

We are following Governments current guidance of not measuring children's temperature when entering the setting, but will check their temperature if in doubt.

themselves. They should wash their hands thoroughly for 20 seconds after any contact with someone who is unwell. Cleaning with normal household disinfectant after someone with symptoms has left will reduce the risk of passing the infection on to other people Line managers will maintain regular contact with staff members/parent of child during this time.
